

RIT looking to \$ell

RIT has been looking to sell its City Center Campus for quite some time, and it's possible that Monroe County agencies might be the ones to fill the space.

County officials are examining a proposal from Spoleta
Construction and
Development Corp. of
Rochester, who would buy the
building and lease office space
to the county. RIT has said
that they already have an
agreement to sell the property
to a private developer, but has
not named Spoleta or given
any specifics.

The move would be important for Monroe County
because many of its agencies
are scattered throughout the
city, including some in the lola
Complex in Brighton, which
the county owns. The deal
would also enable the county
to collect taxes on the property which is now primarily tax
exempt because of RIT's status
as an educational institution.
The property is assessed at
approximately \$6 million.

Any agreement would maintain certain rights for the few tenants now in the building.

W r deployed to Kuwait under an official mission for training Kuwaiti troops.

Joining 1200 American soldiers already stationed in Kuwait, the soldiers can be called to fight if action becomes necessary.

¶ The Pentagon has begun is responding to the complaints of the many Gulf War veterans affected by mysterious illnesses since their service in the Persian Gulf in 1991. As many as 5000 soldiers may have been exposed to chemical weapons during an explosion of an Iraqi weapons depot. This number is much higher than the previously announced estimate of 1100. However, the Defense Department has yet to make any definite statements linking veterans' individual complaints to specific causes.

¶ Spirow Agnew died from undiagnosed Leukemia on September 17 at the age of 77. Agnew was elected Vice President under Nixon for two terms, although he resigned from the position after a scandal in 1973. Ending his political career, Agnew pleaded guilty to charges of income tax evasion.

¶ O.J. Simpson's civil trial began with the start of the jury selection process. One hundred potential jurors will be screened until the panel can be selected. Judge Hiroshi Fujisaki has turned down nearly half of the potential jurors' hardship requests for exemption from the trial. Unlike jurors in the first trial, those selected for the civil trial will not be sequestered. Artists will be allowed to sketch the proceedings, although drawings of the jury members will not be permitted.

¶ Twenty-four year old Todd Hall, accused of nine counts of involuntary manslaughter following an incident at an Ohio fireworks store, has been found incompetent to stand trial. On July 3 of this year, Hall was coaxed by companions into lighting a box of fireworks while inside the store. The resultant blaze killed nine people and injured several others. After the fire, Hall showed little comprehension concerning the impact of his actions. Hall was severely brain damaged in a skateboarding accident, and later underwent a partial lobotomy. He will receive treatment at a mental health facility. No action has yet been taken against the companions who urged him to light the fire.

¶ The abortion controversy has regained political attention. The House of Representatives voted to override a Presidential veto on a bill which would limit certain late-term abortions. This bill would be the first to ban any type of abortion in the years following the 1973 Roe v.Wade Supreme Court decision. The ban focuses on third trimester, partial birth abortions, which are already illegal in many states more rarely performed in the U.S.. Clinton's veto of the bill this April concerned the lack of provisions within the bill for exemptions where the health of the mother is at stake.

¶ RU 486, also known as the abortion pill, has passed major FDA inspections and should be on the U.S. market by early 1997. This non-surgical abortion procedure has been available in France since 1988, but approval in the U.S. has been slow, owing both to the lengthy drug-approval process of the FDA and the often heated abortion debate:

¶ President Clinton declared a 1.7 million acre tract in Utah a federal landmark, naming it the Grand Staircase Escalante National Monument. With this decision, President Clinton placed preservation ahead of economics. In addition to its remarkable and distinctive land formations, this area contains nearly a trillion dollars worth of coal beneath its surface.

¶ Astronaut Shannon Lucid, who has been living on the Russian space station. Mir for the past six months, is preparing for her return home. Atlantis and its crew arrived to transport her back to Earth after her record stay in space. Lucid has now spent more time in space than any other American.

¶ Congress members showed support for mandatory drug testing by voluntarily undergoing drug screening. Texas Representative Joe Barton sponsored "Member Testing Day" in an effort to prove Congress' willingness to set a positive example.

Mending Their Ways

Despite last year's trouble stemming from an altercation with the hockey team, the Tetarton Chapter of Phi Sigma Kappa fraternity at RIT has restructured its goals and in the process earned the Outstanding Chapter Award from its national fraternity. The national fraternity compared the chapter to others of its size based on members initiated, philanthropic events, oncampus participation and academic standards, and presented the award to the Tetarton Chapter. The chapter received the award at its annual leadership meeting on July 27 in Indianapolis.

After being placed on deferred suspension last year, Phi Sigma Kappa sought a stronger relationship with RIT administration. The fraternity worked to form an advisory group including Jackie Reynolds of Industrial and Manufacturing Engineering; Kathy Carcaci and Geri Curwin of Personnel; and John Whitley from the Office of University Research. This advisory group granted the chapter with an ally that "knows the system here at RIT", said chapter president Thomas Golinski.

"This has been one of the most rewarding experiences I have ever had on campus," says Carcaci, who initiated the idea of the faculty advisory group. "This chapter could have just folded. But instead they set a goal for themselves to earn this award."


The previous year's community service events added greatly in the bid for the award including fund raising for the United Cerebral Palsy Association. The group was involved with therapeutic horseback riding wherein brothers served roles as helpers and served to provide safety assistance. The chapter's other activities included the annual Santa Project, Lucky Strike and Cow Bingo which raised 2,000.00 dollars for the Monroe County Special Olympics and helped maintain the Hillside Children's Center.

"Our ideals are to promote brotherhood, stimulate scholarship, and develop character," says Golinski, "These are the principles we were founded on, and these are the principles our brothers live up to every day."

"It took a lot of hard work and cooperation within the brotherhood," said second year accounting major and brother, Robert Pelletier.

President George Bush was on his way to victory by means of a second term. He carried with him many achievements accomplished during his administration, such as starting to heal the national deficit and his decisions to actively pursue peace in the Middle East during the Gulf War. In 1992, he grouped together some of the most promising communication and election campaigners with national level experience and set forth for his re-nomination.

Although George Bush received a five minute standing ovation in the senate after the completion of Operation Desert Storm (Gulf War), the American public thought differently and turned away from the Republican platform because of the recession in the United States at that time. The public was discouraged and tired of losing jobs and they chose Bill Clinton as president instead.

George Bush was the incumbent during the last election in which he was defeated by now President Bill Clinton. In this election, it is President Clinton who is the incumbent and facing the same challenges of his predecessor. The incumbent plays an important role in the election process and, but contrary to what people believe, it is not always at an advantage in an election. The incumbent must deal with two important issues: maintaining an operating government and fulfilling the objectives of the campaign plan.

Maintaining a stable and working government may seem easy for an experienced president, but is not always so. Take for instance the Clinton Presidential train tour that was conducted in August. Instead of comfortably speaking to the people, President Clinton had to allocate time in order to be informed and make important decisions regarding the rising tension in Iraq.

Fulfilling the demands of a campaign plan can be both physically and mentally exhaustive. This means commuting by car, train or plane to many regions of America in order to meet and speak to the people at universities, institutions and work plants. Speeches must be written and delivered. The national conventions demand a profound appearance and presence. Debates and hour long speeches must be carried out on television.

Providing a smooth transition for another party member is also a critical task. This involves persuading the people to believe

not only in the new candidate but also in the party's platforms, ideas and concerns. Usually the best way to deal with this issue is to offer the vice-president as the new candidate such as Ronald Reagan managed to do with then vice-president George Bush in the 1988 elections.

In addition, the incumbent must deal with the past history of their administration. In order to be reelected, the incumbent must prove to the public that the goals and visions of the past campaign were reached. A recent example includes President Bill Clinton's quick and indecisive signing of the welfare reform bill he promised in the 1992 elections. He obviously executed this move in order to fulfill his 1992 campaign objectives. Another example that is easily understood by college students involves Ronald Reagan's campaign when he actively promoted the idea to "get the government off the people's back" in order to defeat then incumbent Jimmy Carter. He even used this issue again when he ran as the incumbent against Walter Mondale, and was successfully elected for another term.

There are twelve factors we can use to possibly determine if the incumbent will be elected for another term (taken from Allan Lichtman, "The Keys to the White House", 1996). If six or more of the following statements are false, the incumbent will most likely not be reelected.

- Party Mandate: More seats are held by the incumbent's party in the US House of Representatives after midterm elections than the previous midterm elections.
 - · Contest: A serious contender for the presidency does not exist
 - · Incumbency: The incumbent is running for a second term.
 - Third Party: A serious contender does not exist.
 - Short term Economy: Economy not in recession.
 - · Long term Economy: Per-capita economic growth exceeds previous two terms.
 - · Policy Change: Major national policies are changed by the incumbent.
 - · Social Unrest: Social unrest does not exist.
 - · Scandal: Incumbent is untainted by major scandal.
 - · Foreign/military failure: Incumbent has no major failure in foreign or military affairs.
 - Foreign/military success: Incumbent has major success in foreign or military affairs.
 - Incumbent Charisma: The incumbent is charismatic or a national hero.

The competing candidate takes on a much different perspective in that there is no national political track record to be considered except with the case of Grover Cleveland who was elected for the presidency in 1884. He lost in 1888 to Benjamin Harrison and then was elected in 1892 defeating Benjamin Harrison. The new candidate will thus be able to choose from a case of tactics to govern his campaign with out any national record on them. Attacking the running administration is an obvious choice, especially when bad decisions have been made. Posing new issues and ideas demands a reaction from the incumbent and may to the the candidates campaign. Other issues may include using the in umbent's track record against him. An example of this tactic used

unsuccessfully was seen in the 1972 George McGovern campaign when he quoted then incumbent Richard M. Nixon as saying "Those who have had a chance for four years and could not produce peace [in Vietnam] should not be given another chance." Nonetheless, Nixon was reelected for another term.

President Clinton is the incumbent in the 1996 elections. He is reminding the public that he has managed to increase the gross product of America and has the economy moving forward. He is signing new amendments and providing extensions to others such as an addition to the Bradley Bill. He is telling the public that he will fund a tax deductible expense to enable people to pay for two years of college.

President Clinton even displayed military power when he ordered 27 Tomahawk cruise missiles to be fired into Iraq, a safe move that guaranteed no lost lives and showed the American public that he can still flex America's military muscle. It is now up to the public to decide based on the incumbent's track record, the new candidate's proposals, and third party's ideas who will be the next president.

Dole's campaign has stated that California is a high priority and that Jack Kemp will focus much of his energy on that State. One might ask then, why did Bob Dole not select Governor Pete Wilson of California as his running mate?

If you remember back to High School, the President of the United States is elected by the the Electoral College. You and I, when we vote for our candidate, actually select the electoral voters for our state. California, being the most populous state, has many electoral votes and is considered a "swing" state by both parties. This means that California could go to the Republican or Democratic candidate, and could mean the difference between winning and losing the election. What does all this

What is the role of the Vice-President of the Unites States of America? Many would say that the Vice-President is the President's right hand man, ready to assume the weighty duties of Commander-in-Chief if the President is unable to do so. But is there more to the job than being the understudy to the president? More often than not, the Vice-Presidential nomination is where the machinations of party politics can be publicly glimpsed.

elected." The Vice-President is selected by the Presidential nominee of each party and then by citizens in the general election in November. What is wrong with that you might ask?

Many studies have concluded that the V-P is selected for reasons that have nothing to do directly with succession. A recent article in Presidential Studies Quarterly stated that "it is difficult to find even one Vice- President nomination that was not made primarily from the standpoint of its utility in carrying a doubtful state or region, or in satisfying a disgruntled faction of the party." For further clarity of this statement, let us evaluate the V-P candidates for the 1996 Election.

As you may know, Bob Dole selected and the Republican Party confirmed Jack Kemp as the Vice-Presidential candidate. Dole's selection is ironic since he and Kemp have argued publicly in the past on fiscal policy. Most notably, the fact that Jack Kemp supported Steve Forbes in the New York Primary. However, an argument can be made that Jack Kemp was the lesser of all evils of those Dole considered for the position, someone who is nationally known and who could broaden his ticket appeal.

So, why did candidate Dole select Kemp? The first reason is that Jack Kemp is an authority on "supply-side" economics, a major part of Dole's 15% tax cut proposal. Kemp therefore, lends credence to Dole's economic platform. Secondly, Jack Kemp brings a balance to Dole in that he is younger and popular across the country. And, Jack Kemp is a stronger candidate than President George Bush's Vice-President, Dan Quale, which helped Bush win the election in 1992.

On the other side of the electoral coin is Al Gore. The Christian Science Monitor reported that the current V-P balances President Clinton's economic shoot-from-the-mouth approach with a reality check. Formerly overshadowed by his wife Tipper, Al Gore has traveled extensively on behalf of President Clinton; an approach hardly used before by past presidents. Vice-President Gore has also worked on supporting NAFTA

(North American Free Trade Agreement) and the National Performance Review (ie. reducing Federal employees).

When former Senator Bob Dole announced that Jack Kemp would be his running-mate, he received a jump in the polls. Kemp provides a stronger message to the general population that both he and Dole should be considered compassionate and moderate Republicans. This surge continued with momentum gained from the convention.

It is this momentum which can be seen on every step in the campaign trail. During the campaign, the V-P Candidate often travels separately from his running mate to "work" the States. Bob

mean? If Bob Dole is serious about winning California, why did he not select a running-mate from the West?

Al Gore on the other hand, has worked not only California, but the entire country for the Democratic ticket. His willingness to travel across the country illustrates his party loyalty and dedication. The Christian Science Monitor recently commented on the improvement of his public speaking and the importance of that to the campaign. In general, the Clinton/Gore candidacy presents a younger, in tune approach to politics that Dole/Kemp can only covet. While Al Gore is not going to start a riot with a speech, he is knowledgeable which should make the

The Vice-Presidency is a unique position in our Democracy. As with the Presidency, the V-P can influence policy and propose legislation. Yet, the V-P is chosen by the Party's Presidential Candidate.

The V-P can be used to unify a split party, moderate a platform, insure broader appeal to the voters, and influence the electoral college balance. When evaluating V-P candidates, it is important to evaluate their potential and to consider their past, because you are in effect choosing the next President of the United States should anything happen to Air Force One. Choose wisely.

"Dissecting"


"What are you dissecting?" He asked.

The internet has a tremendously diverse array of abilities. Those new to the internet will be surprised by what they can do, and the experienced surfer will already know the potential. One of the places where it all begins, especially for those interested in using multimedia on the internet, is

"www.Macromedia.com". This site is probably one of the most interactive ones currently on the net. Maybe I should define interactive, it goes beyond just clicking a button and visiting a new site, or page. "Interactivity" requires the feeling of being a part of what the computer screen is doing. "Interactivity" can range from playing games numbering in the thousands, to sites where just navigating through them demands the user's participation. These sites are created by using *Director* and then added to the internet using a combination of *Afterburner* and *Shockwave*. These applications allow the user to become a part of the internet, with quick response time and fast action. In order to obtain this "interactivity", the user must visit the *Macromedia* site in order to obtain the *Shockwave* plug-in. Once the plug-in is downloaded and filed in the plug-ins folder via *Netscape*, or another Web browser, you have become interactive. Note: you may have to restart your computer in order for it to recognize the plug-in.

Now that you are interactive, you can take advantage of *Macromedia*'s site. Since *Macromedia* is so intent on selling their *Director/Shockwave* idea, they give you a number of different ways to use *Shockwave*. There is so much to do on the *Macromedia* site that you could stay for hours and come back for more. This includes companies using *Shockwave* for business, entertainment, and also for the novice. If you are not sure whether you can click on it, click on it anyway. Virtually everything is interactive on the site. One last reminder, it takes time to download the files, and some of the features are still being experimented on, so be patient. The wait will be worth it.

GREG LOUGANUS

He is proud to say, "I'm gay and I'm proud."

The 1996 - '97 Horton Distinguished Speaking Series blasted off this past Thursday, the 19th, with an emotional and heart warming lecture by Greg Louganus. The evening began with a synopsis of the lecture to come. Alfreda Brooks, the coordinator of the Committee to Promote Pluralism, explained that Louganus would be speaking on his life's accomplishments and struggles. Describing him as a "Champion and an exceptional human being."

Louganus has received respect and admiration for the past two decades, in light of his outstanding diving career. These

As the lecture moved on, the audience became more and more attentive and the emotional pace quickened, as Louganus began talking about the next transformation his life took, H.I.V. status. In "88, after his lover was diagnosed with Pneomocystic Phenomena and full blown AIDS, he found out that he tested positive for the virus. After finding out the results, he wanted to lock himself in his room and wait to die. Fortunately, his doctor, who also happens to be his cousin, stated, "Were going to treat this seriously... and go for the gold" by working as a team and combining heavy medication with training. This combination, as Louganus and the rest of the world would soon find out, would work to win him his second dual gold's. However, the tough regiment left him crawling to the bathtub nightly, in order to relax his muscles.

Next came the "87 Olympics and along with them, grave tragedy. This is the everlasting moment in the publics' eye, when Louganus hit his head during competition. Even though he went on to win dual gold's for the second Olympics in a row, Louganus was terrified. He didn't fully understand what his responsibilities should have been with respect to his H.I.V. status. However, he soon found comfort in the words of his friend and doctor, who rushed to his aid at that time. The Doctor stated that, "He took every precaution possible and wasn't even concerned with the situation."

After accepting his new life and the hardships he would have to endure into the future, Louganus was able to move on, dealing with his situation in many different ways. At this time Louganus realized that, "The truth shall set you free" and began his crusade with an auto biography, which will soon be made into an HBO movie. He has also opened the arena to acting, which has been a love of his life since his college days. He starred in a play called leffrey, in which he played the part of Darius, a gay man, who is out and loud about his lifestyle. The play ends in tragedy, when Darius dies from Aids, delivering the message, "Hate aids not life." Louganus said that this experience allowed him to better cope with his own problems and begin to move on with his life.

accomplishments include an Olympic silver medal in the platform at age sixteen, two Olympic gold's at the age of 24 and the exceptional feet of back to back double gold's at the following Olympics. Furthermore, he was appointed the Maxwell House athlete award, meaning that he displayed the most Olympic spirit, courage and contributions to his sport. His diving career can be summarized by this quote from a sports reporter, "There are two categories of divers, those with magnificent skill, grace, beauty and courage, then there is Louganus."/ However, even with all of this triumph, most of Louganus' life has been tragic, which is the interesting twist that the lecture took. This made the lecture fun, exciting and full of emotion, because the subject allowed for great openness, which lead to quite a worthwhile experience. Everyone who had something to say just wanted to commend Louganus' ability to be so open, about subjects like his sexuality, his past and hopes for the future.

Louganus opened his speech with this message, "Believe in yourself enough to protect yourself." This is because he is upset with the current way many deal with their sexuality, stating that, "We know how to prevent H.I.V. and AIDS, but many times the problem lies in the area of self-esteem." From that point, the lecture turned to the topic of "Coming Out", and it was here that we learned of Greg's struggle with his own sexuality. His brief review of how he discovered his own sexuality and how he dealt with it during his time at U. of Miami, was received with loud applause from the entire audience. Fortunately for Louganus, his mother took the news as well as his audience did that night. Louganus stated Louganus that she appreciated the time he spent with her son, commenting that she was overly accepting of her son's sexual orientation and went on to explain that she finds his friends and way of life fun and exciting.

However, Louganus would hide this secret from the public eye for years to come. Louganus explained that, "[He] wanted his diving to speak for itself." Finally, able to better deal with the truth, Louganus decided to enter the Gay Games, thinking that this would send out a message to the general public that he is gay. However, his plan back fired. After the Gay Games, while receiving an award from the U.S. Olympic Committee, he opened his remarks by thanking the committee for awarding an openly gay athlete. Well surprise, surprise, the general public missed the airing of the gay games and more importantly, was shocked and astonished by his remarks. At this point, he began to realize that not everyone would be as accepting as his own mother was. Now, in 1996, Louganus feels that it is his job to try to change peoples perceptions with the backing of his championship status.

The final theme of the lecture is Louganus overcoming tragedy. This is where he began to explain some of the things that gave him the ability to cope with his complex life and to fight against his clinical depression. Upon being referred to a new therapist, Louganus' life took a major turn for the better. For the first time in his life, Louganus was made aware of the root of his problems: depression. It was at this time that he became aware of his own personal and positive qualities and realized that he didn't deserve abuse from lovers, which he now realizes he did not deserve. Considering the tragedies that Louganus experienced in his life, one can imagine how depression could easily set in. However, Louganus states that after realizing quality of life is the most important factor in happiness, he was able to easily move past it. His autobiography acted as another factor in his fight over depression. After reading it three times, he began to realize that it described the, "Experiences of a survivor, who had to use his intelligence to overcome."

Louganus mentioned that all of this lead up to a cathartic experience, which allowed him to finally see the beauty in his own dives. Now Louganus is touring the country, giving lectures and doing book signings. Truly Louganus has become the role model of the 90's, receiving such comments as, "Your book saved my life," "I'm fighting the same battle as you," and "Thanks for being there." One thoroughly impressed mother went on to tell that he couldn't stop raving about Louganus.

What does the future hold for Greg Louganus? Well, he is looking forward to continue acting, in both t.v. and film, which could lead to continued success. to purchase goods, and can be used around the world. There are many propositions, however, that can make credit card ownership a very expensive convenience. Expenses such as: annual fees, annual percentage rates (APR), and missed payment fines can easily add up to put the owner in serious financial trouble. A January '96 issue of Consumer Reports stated that 2.4 billion credit card offers were mailed to US households last year and 460 million

cards are in circulation. Judith Stevens of Consumer Credit Counseling (CCC), a non-profit national organization, revealed the startling statistic that total credit card debt in this nation is 5,000 dollars for every person 18 and over. Without reading the fine print on credit card applications, it is easy to see while college students are particularly prone to credit card debt.

Students at RIT are certainly not exempt in the growing of this large credit debt. Photo student, Kim Batkowski, is no stranger to the woes of credit cards. "I'm an adult now, I guess I'll get a credit," is the attitude that she and many other students have when starting their college careers. Judith of the CCC stated that 65% of college freshmen have credit cards by their second year. Last year Kim acquired the RIT, Mastercard and Citibank cards. After she missed one payment on her Citibank card the interest rate was raised from 6.7 to 9.7 and a 20 dollar fee was applied on all future activity. After a few months of paying the minimum payments on her Mastercard, Kim had 50 dollars added to her bill. She currently is 2,000 dollars in debt, after using her card exclusively to purchase photo supplies. Kim also stated that only the RIT card had "fairly low rates."

Why do credit card companies target perhaps one of the poorest segments of the American population? The answer is simple. The fact that credit card companies make their money from people in debt is undeniable. So despite the fact that many college students have little or no income, the same student who has eaten only Ramen noodles for a weak is eligible for many of the pre-approved cards offered. A Credit card company's best customer is one who maintains a monthly balance. So students, those who have poor payment records, and even people who have declared bankruptcy can still easily obtain credit. Credit card companies are especially attracted to students because many parents are willing to co-sign, and therefore bail their kids out of their first financial trouble. Judith Stevens of Consumer Credit Counseling expressed concern towards the current trend of the credit targeting of students, "A decade ago, a

26 year-old in bankruptcy was unheard off, today it is quite common." She also understands the lure of the credit cards and said, "It starts of with students buying necessities and things like bookshelves, and the next thing they know they have a new stereo an are 2,000 dollars in debt." Many Students tend to have a "seize the day" type of attitude and that they can worry about payments after they graduate and get a job. Credit card companies often lure students with the promise of no annual fees. Although this certainly is a beneficial feature, card companies such as Citibank, which highly solicits college campuses, has a interest rate as high an 17 to 18 percent.

The January '96 Consumer Reports published many tactics which credit card companies use to increase the balances of its customers. Hidden in all the fine print which plasters all credit card applications are often agreements which allow the card company to jack up your APR after learning that you have debt with other companies. Offers for many pre-approved credit cards contain enticing APR's of 6.7 or 8 percent are often only valid for a few months when the rate could increase to as much as 18 percent. An anonymous friend of a Reporter staffer received an APR of 20% after failing to pay credit card bills for 3 months. After going on co-op and paying off a large amount of debt he said that he now owes \$600 on another credit card because "You buy a few things, and in a couple of months it catches up with you." He also has a 23 year-old friend who is \$14,000 in debt mainly because of cash advances on credit cards. Cash advances are encouraged by card companies and usually are not covered under low "teaser rates." Cash advances also often contain a fee of 4 percent added on. Not even hidden in the fine print, the card company First USA has a clause where even if you paid the previous month's bill they can assess new interest charges based on what you once owed. Cardholders are also graciously offered to "skip a payment," on which the card company gets to charge interest on top of previous interest. Consumer Reports also revealed that card companies often jack up the price by increasing the APR of those who have a high balance, but have not been making many new charges. Card companies also have switched customers who have paid in full each month to a card with no grace period that begins charging interest from the day of purchase. Bank of America card holders are even required to sign away their rights to take the Bank to court over a dispute. And remember since card companies stay in business because of debt, those users who don't use their cards often and always pay their bills can find their accounts mysteriously canceled.

What can you do?

Judith Stevens of Consumer Credit Counseling suggests that college students not even acquire credit cards. She said, "When friends know a friend has a credit card they are inclined to suggest putting things like dinner tabs on a credit card." Stevens expressed that "This just one of the many ways students get into trouble." For those who insist on having credit cards, she suggests using them for emergency purposes



only. Stevens also suggests paying more than 2 percent on a credit balance because, "If you pay only 6 dollars out of 20 then you still have \$14 just as interest." Perhaps the most valuable information for those who currently have a credit card is the fact that you can usually get your interest rate lowered just by calling your credit card company and asking. Judith suggests that students read all off the fine print and ask themselves why they want a credit card before ever acquiring one.

If you are wondering what to look for in a credit card, there are basic things which are critical to an intelligent choice. I. As stated by Consumer Reports, be sure to read the fine print for

I. As stated by Consumer Reports, be sure to read the fine print for hidden clauses which could cause you to have serious financial problems. 2. Is to avoid an annual fee because even if you pay off your bill every month and do not have to worry about interest this expense would remain. 3. Shop around for the best rates because the APR will make a huge difference if you plan to have balances from month to month. Unfortunately card companies which are offering low APRs are often picky about whom they allow as cardholders and turn down people who would benefit most from low rates (such as those with substantial credit card debt).

Beyond the novelty items there are some credit card perks which are

ranties beyond that of the manufacturers often need to be registered first. There are also offers for legal services for 10 dollars a month, but you are charged for something more than very simple legal matters. Some banks also offer interest payment refunds, but for a "100%" rebate by *Mellon Bank* you have to wait 20 years. Credit card companies are also making a lot of money off of insurance deals which promise to pay your credit card if you become unable to work. Not many of those who pay a few dollars for this perk ever use it and when they do only the minimum payment is made.

For those of you who are already in credit card debt the best thing to do according to Judith Stevens at Consumer Credit Counseling is to "Immediately get rid of all your cards.. It can lead to only one thing: more debt." If possible, you should try to get financial support from family or friends to try to pay off this debt. If not, substantial debt will plague your credit record and make it difficult to receive necessary loans. The Monroe county branch IRS approved non-profit organization Credit Counseling Centers of America offers private counseling to help people get out of serious debt. If you qualify for their program they will establish a repayment program to get you out of debt in 3-4 years. They suggest that the worst thing you could do is file bankruptcy and recommend doing anything possible not to resort to that.

The issue of privacy is another concern you should consider before applying for a credit card. Consumer Reports revealed that card companies use services which teach them how to determine information about your "income, your age, what you buy and where, where you travel to, your leisure activities, the magazines you buy and even the type of birth control you use." Companies can then sell your demographics for a hefty profit to the highest bidder leaving a flood of junk mail in your mail box. And the government has no restrictions on these practices. There are some card companies



however which have made ethical decisions concerning the distribution of this information. American Express will not reveal purchasing information and gives customers the option of having their name taken off of mailing lists. Chase Manhattan Bank won't sell information about its cardholders, but will give it to business partners such as British Airways.

An immediate affect on the privacy of any cardholder will be felt through phone solicitation and payment reminders. If you miss a payment be prepared to get numerous calls, many of which will mislead by saying you don't have to pay right away or in full. If you let your debt get the point where an individual collection agency is hired to obtain the money for the businesses which are owed, expect a relentless amount of calls and hassle. The credit card companies will continue to benefit from your interest, so it is unlikely they will threaten you with anything but payment fines. Card companies are certainly not prone to mistakes. Mark Bray, the RA on the first floor of NRH, had American Express call his house in Maryland and claim that he owed them \$808 when he didn't even have an American Express card! After weeks of being harassed by American Express, they found out it was a case of mistaken identity his parents had to change their number listing. He then had to labor through hours on the phone with the credit bureau to fix his credit rating. This is just a case of how information can easily be mixed up and suddenly leave you with unforeseen problems.

The two major brand names of cards, *Visa* and *Mastercard*, account for more than 85 percent of all US. charges. It is the thousands of companies which issue these cards which determine the interest rate and fees that are charged. Despite competition among companies the average interest rate is 17.98 percent. The reason for this as suspected by *Consumer Reports* is that people do not shop around for a good interest rate the way they do on a mortgage. It is critical to be educated on the high risk involving the owning of a credit card to avoid fate of debt and bad credit. Too many students are lured by the feeling getting anything you want by the magic sweep of card. For those of you who now have twenty cards because you couldn't resist all the free stuff, think of those offers as a game of skeeball. Sure the fluorescent walkman for 5,000 points is cool, but after sinking forty bucks into the game you could have bought four walkmans, and now all you have is another plastic whistle.

ou may have noticed a proliferation of political ads on television lately. Perhaps your favorite show has been preempted by one of these older men in suits talking about things like the national debt or health care. If you haven't heard it before (or figured it out from the signs up all over) this is an election year. What does that mean to you? It means that pret ty soon people will be making decisions that will effect the rest of our lives, the same decisions you should be a part of making. Some people on the RIT campus think that the upcoming election is important. If you've been through Gracie's or Hettie's during the week you've probably noticed some people sitting behind tables with stacks of forms and signs that say something about taking responsibility for our future. These are some of the people on campus that think the upcoming vote is an important one. They're the members o Hillel (RIT's Jewish Community), Student Government and Community Service Club House (CSCH).

These three student organizations have gotten together to give everyone else who comes through this campus a chance to let their voice be heard, not only in the upcoming election, but in all elections that follow it as well. Their goal is to get as many people registered and ready to vote as possible.

Why the big push this year, you ask? Well, aside from it being a presidential election year, this is also the first year that generic forms have been available for registration. For the first time, students can register using their on campus address and then vote locally, in this district. The thing that students choosing this option should keep in mind, however, is that once they register here, they cannot vote elsewhere without once again changing their registration.

Other options open to students include sending in the new generic registration form to their home board of elections and forms for absentee ballot acquisition. The first option would allow someone who is not already registered to vote the ability to register in his or her hometown, giving them the right to vote in the same elections and on the same issues as their parents. The second option is for students who are registered outside of the Rochester area and would like to receive an absentee ballot. This would also be a handy form to pick up if you were to register as an out of state voter.

How did all of this come about? Just ask Ron Goldberg, a student involved with Hillel. He went to their national convention at the end of August and found out about the initiative similar groups around the country were taking. All-he-

did was step up and express his interest, and he was handed an information packet and told who to get in touch with. Working hard to get everything set up in time to meet the deadlines of most states' voter registration (some are as early as October), he contacted people here at RIT and got permission to set up tables in the lobbies in order to register students to vote. Almost immediately he came across two groups very willing to help his organization, Student Government and the Community Service Clubhouse. The purpose of these these organizations' campaign is to make it easi

er for you to register to vote and let your voice be heard

Why vote? Because it can make a difference. Any number of elections and decisions could have turned out differently if less (or more) people had felt the need to express themselves. If, in 1776, one person had decided it wasn't worth it to vote, English and German would have tied for the official language of the United States. One hundred years later, the same margin allowed the French to break the monarchy and change their country into a republic.

This year there is no excuse why you shouldn't vote if you are eligible to. The members of three RIT organizations are trying to make it easier for you to register or obtain an absentee ballot Both candidates have web sites and information on where each candidate stands on the issues can be seen in most newspapers and magazines. If all else fails, there is no shortage of opinions on who would be best for the position of president. Just ask anyone who turned on the TV expecting to see their favorite sitcom and found Ross Perot, Bill Clinton, or Bob Dole talking about what needed to be done with this country in order to make it better for our children instead.

Our children. To some of us that seems like an odd concept. Why would we even bother with something so far off? How could something as simple as checking off a box or two on a piece of paper and dropping it in the mail effect our children, years from now? Ask yourselves these questions, and then think. Our parents were told the same thing. Are you happy with all the decisions they made? If you aren't, then now is your chance to do something about it. If you are, then this will be something you can point to when your child is being difficult. You can point to a line in a magazine or a newspaper and say, "I was part of that decision. This is what I did to make the world what it is now."

If for some reason you missed the tables, forms can still be obtained at the Interfaith Center or from the Monroe County Board of Elections. Take responsibility for your future and vote this November.

In the 1988 presidential election, only 36.2% of college age people voted. Not even half of the future leaders of the country cared enough to let everyone know who they thought would be right for the Presidency of the United States. Who knows how differently the election would have turned out if these young Americans had set an example for their parents and peers.

In the '92 election the numbers were much better, coming in at 42.8%. Still not half, but a few percent more than four years earlier.

In the 1994 election, the number of young voters again dropped considerably, to between 20% and 30%.





A Disappointing Week for Women's Soccer


