An amendment was made to exclude voting on Technila with the other budgets also. It was seconded and passed to discuss Technila separately. The motion was carried to vote on everything but the Modern Jazz Society and the Archery Club and Technila as a group.

The previous question was raised, seconded and passed. It was moved, seconded and passed that we next consider Technila. Considerable discussion followed as to whether " the best yearbook in the country" could be published with the addition of funds to the Technila budget. The previous question was moved and seconded . It was moved to accept the Technila budget at 17.500.00. The previous question was moved, seconded and passed. The main motion was passed by a vote of 19 to 17.

It was moved and seconded that the Modern Jazz Society be considered separately from the Archery Club. The previous question was moved, seconded and passed. The main motion was also passed.

Tom Ganon moved that the budget for the Modern Jazz Society be accepted. It was suggested that the Society take over the Jazz Concert to be given by the Student Association and be allowed to have two concerts instead of one, as would be covered by the \$500.00 recommended budget, and rel ve the Social Division of sum of the responsibility of putting on open functions.

It was moved and seconded that we table the Modern Jazz Society and the Archery Club until we can hear from a representative from both organizations. The motion to table was carried.

It was announced by Dick Borghi that the upperclassmen would receive their Activities Cards on October 8, 9, and 10th in front of Room 125.
