The minutes of the previous meeting were read and corrected.

President Boston announced that a majority vote must be secured in order to table a motion.

Harris Rusitzky informed Council that a city ordinance states that any public broadcast is illegal. Edgar Watson suggested that Council send a letter to each organization informing it of the rules and laws concerning any public broadcasting.

Harris Rusitzky also reported to Council that he had investigated the possibility of having stop lights placed at the corner of Spring Street and Plymouth Avenue, and that it is being seriously considered due to the number of accidents that have occurred here.

President Boston reported the Senate recommendations concerning regulations for student offenses. The recommendations are as follows:

- (1) Each Council member is responsible for speaking to an offender. He must also take the names of offenders to the Student Council Office. Lounge Committee members are to make it a point to be in the lounges at least 3 times during a week.
- (2) For the first offense a warning will be given.

 For the second offense a student will appear before the Senate and will be fined.

 For the third offense a student will be placed on non-academic probation.
- (3) Fines are to be a maximum of \$5.00. The degree of the offense and the accompanying fine are to be determined by the Senate. All fines must be paid within 30 days; failure to do so will automatically place the student on non-academic probation.
- (4) The above regulations pertain to conduct on school premises particularly in the halls and lounges.
