Dan McGillicuddy announced that a motorcade to the Student Council and Awards banquet will leave Kate Gleason Hall at 5:45 P.M. Anyone who can provide transportation should see Dan.

Jim Coleman reported that it is possible to lock a parking lot at 10:30 P.M., and open at 7:15 A. M. Dan McIllicuddy moved that one parking lot be locked at 10:30 P.M. The main motion was amended to specify the Troup Street parking lot. The amendment was voted upon and passed. The main motion as amended was voted upon and passed. It was then moved that the locking of one parking lot begin Monday, May 15, 1961. This motion was voted upon and passed. Bill Halldow requested a sign stating these regulations be posted at the parking lot. Jim Coleman will check on the possibility of leaving the light on all night in the other parking lot.
