Organizational Affairs - John Snyder

John Snyder moved that Student Council approve the following policies concerning the bulletin boards regulated by the Organizational Affairs Division: (1) All material to be poster is to be stamped by the Student Activities office before being posted. (2) All material is to appear on 4" x 6" cards, with the exception of organizational posters, flyers, and any other material approved by the Division. These cards are also available in the Student Activities office. (3) These policies will become effective Monday, January 21, 1963. The motion was passed unanimously. A letter will be sent to all organizations stating that a registration calendar for reserving bulletin board space will be located in Mr. Walls' office.

John Snyder moved that Student Council approve the constitutions of Delta Omicon, Young Democrates, Demolay Club, ACS, IRE, Lettermen's Glub, DLE, and the RIT Rifle and Pistol Club. The motion was passed. A new local, social Fraternity, Kappa Fhi Omega, has submitted their constitution to Council Approval.

John Snyder recently attended the FEOFLE TO FEOFLE CONFERENCE which stressed the impostants of international relationships on campus. Since, comparitively, RIT has a large amount of foreign students, it would benefit the whole student body if a program could be coordinated.

John Snyder moved that a letter be sent to all area colleges encouraging rotating conferences. These conferences would stress related campus activities such as supporting "big name" entertainment on the various campuses. Mainly the conferences would be used as discussion area for problems and ideas. The motion was unanimously passed.

COMMITTEE REPORTS

NSA - Lloyd Beard gave a brief summary of the aims, purposes, and opportunities of the National Student Association.

Student Union - Presently there will be no more noon-time movies at the Union. More publicity and a new sourse of movies were suggested to encourage better attendence in the future. The student body is individually encouraged to join the ping-pong champeonship at the Union.

The motion was tabled.

Dan McGillicuddy, Mike Volkhardt, John Walther, and Bill Wing have telinquished their Student Council duties since they have been placed on Scholastic Probation. The President nominated Dean Crawford for Social Division Head. The nominations were closed. The remaining nominations will be made soon.


