RETREAT REPORT MARCH 15-16, 1963

Keynote address - Dr. Campbell

"Any organization to be successful must first establish objectives and then have a basic understanding of its objectives. Student government is established to serve the used of the student. It gives the student an opportunity to learn the techniques of self-government. It is a mediator and creator of activities for the welfare of the student body and to verning group for the establishing and maintaining of social, cultural and academic standards of the student community. Only the student government which has developed its areas of responsibility to include legislative, administrative and judicial activities has progressed toward the fullest potentiality within the true concept of self-government."
