Student Council Minutes
November 14, 1963

The regular meeting of the R.I.T. Student Council was called to order by the President, Ron Sherman. Roll Call was taken and the minutes of the previous meeting were approved as read.

PRESIDENT'S REPORT

Spring Vacation-Dr. Smith approved the following recommendation for spring vacation: The Institute will close at the end of exams Thursday, March 19. Registration for spring quarter classes will be held Monday, March 30. Saturday classes on April 4 and April 11 will make up for the classes which we will miss.

Another lecture on "Abundance" will take place at 4 p.m. on November 20 in the Student Activities Center.

Police Chief William Lombard will speak to Student Council next Thursday, November 21. Any interested students may attend this meeting of Student Council.

Miss Hogadone, Dean of Business College, has requested that students refrain from playing cards at 50 Main Street in the snack bar.

The results of a meeting held with leaders in the Third Ward was discussed. It was suggested that the campus should have better lighting facilities. It was also noted that the police are patrolling this area.

No student can represent the Institute if he is on probation. Awards were granted for the Golf, Tennis, and Baseball teams. There will be seven girls on the cheerleading squad. The Tech Tourney will be held on December 27, 28, and 29. The summer wrestling clinic was a success.

Constitution Committee-Dave Smith recommended that we defeat Gary Proud's motion.

OLD BUSINESS

The constitutions of Delta Sigma Pi, I.F.C., Letterman's Club, Photo Society, and Phi Sigma Kappa were approved by Council.

NEW BUSINESS

It was moved that Council donate \$15 to the N.A.A.C.P. It was moved and defeated that we amend the motion and send them a letter instead of \$15. The main motion was then defeated and the matter dropped.

It was moved and passed that we reinstate as campus organizations the American Society of Tool Engineers, the Bowling League, SMPTE, and Tau Kappa Alpha until December 9, 1963.
