

The meeting was called to order by Vice President Tom Stash at 7:05pm. Following the opening prayer, the roll was called, minutes read and approved.

Mr. Benz was to give a presentation on the Auxiliary Services and because of illness Mr. Tollerton gave it in his place. Everyone was given speaking privileges and Mr. Ford was present a one of the authors of the letter sent to the complaints committee concerning the Auxiliary Services. The letter was lodged as a question and not a complaint and Mr. Tollerton was present to answer these questions.

**Chairman's Report:** The summer College Union Fee charged the Business Students is not correct and will not be charged until the Union is opened. But Summer Quarter Tuition will be the new tuition for all the Business Students, only. Thursday, February 23 is the meeting with Dr. Ellingson for the Senator at 4:00. The Senate Newsletter is delayed in coming out because of General Duplicating.

**SAB:** The Area College Constitution was presented at the Feb. 13 meeting and a motion was made to ratify it by Senate. It was seconded and passed. Feb. 23 is the meeting at Gamzeo to ratify this constitution. Senators mentioned point that they would like changed. Resolution #33 was presented and referred to the Acc. Affairs Committee. It concerned the evaluation of teachers and courses. Winter Concert was a big turnout and better than was expected. Mr. Proud presented Resolution #34 which was a Statement of Policy. It was passed. Resolution #35 concerning Student Alcoholic Regulations for the New Campus was presented. A motion was struck at SAB and Mr. Hanson moved that this be added again as an amendment. It was defeated. Mr. Hanson then presented a new amendment which was defeated. Mr. Howard Hansen presented an amendment and a roll call vote was taken the results as follows: 12 eyes, 4 nays and 1 abstention. The amendment was defeated and the discussion was then on the Resolution as stated. A roll call vote was again taken and the results were as follows: 13 eyes, 4 nays. The Resolution #35 was passed. Leadership Conference is March 4 and reservation forms were filled and returned to Bill Blaufaus.

**Advisor's Report:** A statement was made concerning the Unsensored Press "A reluctance on the part of any student contacted who would willingly go through the process of setting up and incorporating an Uncensored Press independent of the Institute,"

- b) libel

The paper is completely student financed. Selina Zygmunt is now the editor of the Reporter.

Bruce Baumgarten stated that there will be a check-cashing service at the new campus and Postal Service.

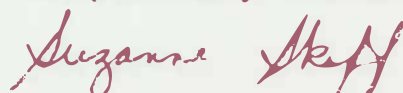
Nominations remained opened.
