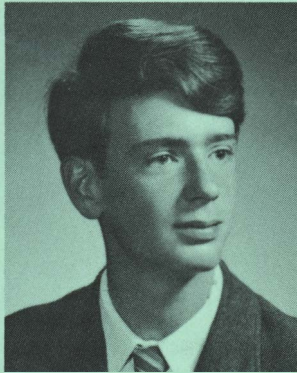


'Outstanding Student' Winners Named

President Paul A. Miller and Donald A. Hoppe, Dean of Admissions and Records, have announced the winners in the Outstanding Student Awards competition for two \$9,000 RIT scholarships to freshmen entering the Institute next fall.

The winners are Douglas G. Batt, from North Tonawanda, N.Y., and Venita D. Shelton from St. Louis, Mo.

Douglas G. Batt is from North Tonawanda Senior High School, North Tonawanda, New York. In addition to distinguishing himself during the competition week-end, Douglas has been the winner of a wide range of math, science and other awards indicating high scholarship from his school, his community and his state. His other activities range from membership in an Active Citizens of Tomorrow Club to a place on his High School team for the TV show "It's Academic". He will be registering in the Chemistry Department at RIT.

Venita D. Shelton is from Roosevelt High School in St. Louis, Missouri. The reasons why Venita has won eight "R's" for Scholarship and Service at Roosevelt High were made clear during the competition week-end. Some other ways her scholarship has been recognized are her status as a "High School Senior Scholar" at Washington University in St. Louis, her membership on her High School team for the radio program "Scholar Quiz", and an early commitment for cooperative employment with a major company when she reaches that point in her Electrical Engineering program at RIT.

The winners were chosen from 107 of the nation's top high school seniors who took part in an invitational competition week-end at RIT in February.

All participants in the competition weekend received a \$50 RIT book prize.

'Radionics and Radiesthetics'

"Radionics and Radiesthetics," a lecture on the techniques and application of bio-electronic measurements, will be presented Wednesday evening, April 5, at 8 p.m., in St. Basil Hall at St. John Fisher College.

The program is being sponsored by the Extended Services Division of the College of Continuing Education at RIT in cooperation with the Northeast Region, Spiritual Frontiers Fellowship.

Presenting the lecture and demonstration will be the Rev. Father Anselm Ober, a Benedictine monk who is one of three priests at the Church of St. Gregory the Great in Virginia Beach, Va.

Roger K. Powell, director of liberal studies in RIT's Extended Services Division, said Fr. Ober will present "an explanation of how attitudes, feelings and emotions direct and influence your life via the subconscious.

"This program should attract all persons interested in the new fields of directing and calibrating problem areas in the individual--those exploring the effects of the subconscious on a person's life."

Cyril T. Tucker, of 377 Glen Ellen Way, Brighton, chairman of the Research Subcommittee on Survival for Spiritual Frontiers Fellowship, explained Fr. Ober's work as follows:

"Father Ober was an assistant at Boys' Hospital, teaching psychic neurology, during World War II, and in assisting the chaplain at nearby service centers found out that the soldiers needed psychiatric attention more than they needed theological counseling.

"He continued his studies in this field, adding work in homeopathic and naturopathic therapy. Being technically minded, he studied human energy fields, perfected a device for measuring them, and developed a complicated system of charts to guide him in discovering problem areas in the human menage, whether in the physical body, the astral body or the etheric body.

"I believe this roughly corresponds to the body, mind and spirit. Fr. Ober calls this the science of Radionics. He connects you into the system by placing a metallic plate between the palms of your hands, and after discovering the problem area, tests for a cure by placing an indicated remedy into the circuit and testing for resonance.

"The basic test is one for levels of consciousness compared with the level of the unconscious. On a scale of 1 to 100 the conscious level should be in the proportion of about 85 to 30. If the subconscious level is higher than the conscious level the person has trouble relating to the environment.

"In addition to the problem cases in his own parish, which he handles as part of his work, Fr. Ober handles cases from all over the world, the latest being from Algeria."

As further explanation, Powell noted:

"An individual is a composite of many force fields. His body is a molecular organization of atomic force fields operating under many others--metabolism, gravity, light, and heat. Much progress has been made in instrumentation of a person's condition, such as the electrocardiograph for heart measurements and the electroencephalograph for states of consciousness."

Admission for the lecture is \$2.50 for adults and \$1.50 for students. Further information on enrollment may be obtained from Mr. Powell, Ext. 2213.
