He earned his bachelor's degree in business administration from Northeastern University and earned his MBA from the University of Rochester's Executive Development Program in 1975.

VandenBrul Creates Award To Honor Entrepreneurs

A new endowment fund has been established in the College of Business to recognize the importance of entrepreneurs to Rochester's economic life.

Created by Herbert W. VandenBrul, a founder of R. F. Communications, the endowment fund will support a distinguished lectureship, the Herbert W. VandenBrul Award, and will also support a student award.

"The College of Business, as well as the RIT community, greatly appreciates this award. The generous gift donated by Mr. VandenBrul is a significant example of the long and close partnership between Rochester business and industry and the Institute. It will also enable our students to have contact with, and learn from, successful entrepreneurs," said Dr. Walter McCanna, dean of the College of Business.

The Herbert W. VandenBrul Award will recognize an individual who has successfully developed an emerging business that improved Rochester's economic life or whose innovative management skills have changed the course of an existing business.

The first recipient of the award will be invited to lecture in October. The recipient will be selected by representatives of the College of Business as well as by several civic and business leaders.

A College of Business committee will select an outstanding graduate or undergraduate student to receive the student award.

Signifying the spirit of the entrepreneurial award, VandenBrul was one of the





Personnel Announces Supplemental Dental Plan for Permanent Staff

As a supplement to the Institute's dental assistance program, RIT has arranged for favorable fees for RIT personnel and their families with several local providers of dental care.

The arrangements for favorable fees is available to all permanent employees and to retirees of the Institute, groups not covered under the basic dental assistance program.

"It is our hope that this program will address some of the concerns expressed by employees regarding the amount of out-of-pocket expenses required by regular dental service providers. We realize that this program will not provide a solution for employees who do not wish to change dentists, but the program will provide employees with an alternative," says Jeanne Healy, director of Personnel.

Healy explains that RIT annually tries to improve benefits to employees including reimbursement amounts paid under the present dental assistance program. "With a \$500,000 rise in the the cost of health insurance benefits, we are not able to upgrade the fee schedule. We look at this arrangement as an alternate method of improving this important benefit," she says.

There are no special procedures for establishing an appointment or seeing a dentist associated with RIT's Smiles Preferred program. Employees and retirees can present their RIT photo identification cards to identify them as RIT employees covered by the Institute's dental assistance program. All Smiles Preferred dentists will have a supply of the appropriate claim forms.

According to Chuck Hayes, benefits administrator in Personnel, part-time employees and retirees will be sent optional verification/identification cards for use at Dental Associates in the mail within one month.

Executive Program Fellowship Available to Administrators

Full-time RIT administrators can apply for the 1984-85 RIT Executive Program Fellowship awarded annually by the Institute.

Designed for Rochester area upper- and middle-level managers, the RIT Executive Program is presented in 20 weekly sessions from October through April during each academic year by the Center for Management Development (CMD), College of Business.

Dr. Philip R. Tyler, CMD director, coordinates the RIT Executive Program. He says, "The typical participant is between 36 and 55, manages 20 to 600 persons and is very concerned with the need to keep current." Tyler adds that participants have an average of 10 to 30 years of management experience.

Administrators who wish to be considered for the RIT Executive Program Fellowship should have 10 years of management experience, currently manage 10 or more professional/managerial personnel and have responsibility for personnel and budget evaluation. In addition, applicants should have a background that is compatible with the industrial managers in the program, a

desire for professional growth and job responsibilities that would not interfere with class attendance.

There is one RIT Fellow selected each year.

Persons interested in applying for the RIT Executive Program Fellowship should apply by letter to Dr. Thomas Comte, associate dean, College of Business.

Regents To Honor Frisina With Medal of Excellence

Dr. Robert Frisina, vice president and secretary to the Institute at RIT, will receive the Regents Medal of Excellence from the University of the State of New York Board of Regents on July 18.

Frisina will be honored for his outstanding contributions on behalf of disabled individuals during ceremonies in Albany marking the Regent's bicentennial celebration.

According to Chancellor Willard A. Genrich, the July event will be one in a series of programs that will consider ways in which education can address issues concerning society.

"I have intended that the results of my experience in administration, planning and research be contributed in part to the community through involvement in health and human services programs," says Frisina, who holds directorships in the secondary and special education, hospital, community and business areas.

Frisina is an international lecturer in the area of deafness and a consultant to several state departments of education.

He played a leading role in developing the National Technical Institute for the Deaf at RIT and served as NTID's director for its first 10 years. Since 1976, he served as RIT's senior vice president for Institutional Advancement. He is responsible for RIT admissions, communications, financial aid and institutional research.

During the past several years, Frisina has served as chair of the Regents Advisory Board, New York State School for the Deaf in Rome, N.Y., and on the boards of directors of the Conference of Executives of American Schools for the Deaf, the Alexander Graham Bell Association for the Deaf, the Council on Education of the Deaf, the Rochester Speech and Hearing Center and the Rochester School for the Deaf.

He is current chairman of the Upstate Health Systems, Inc., and the Frank Gannett Newspapercarriers Scholarship Program and is former chairman of the board of directors of Highland Hospital.



Three College of Business faculty became jet set educators this spring as faculty members Dr. Robert Barbato, Daniel Tesson and Dr. Stanley Widrick each spent two weeks at Sheffield City Polytechnic in Sheffield, England.

The three each lectured to classes at Sheffield City Polytechnic and did individual research while in England.

In March Dr. Stanley Widrick, the J. Warren McClure Professor in Marketing, went to Sheffield where he conducted seminars for the faculty of business and management studies in the department of economics and business studies.

Widrick began arrangements for a series of marketing seminars he plans for fall and spring in London, and in New York City, San Francisco, Chicago and Dallas.

Widrick explains that one unexpected pleasure of the trip was staying with Sheffield faculty while he was teaching. "It was rewarding both professionally and personally," he says. "As a result of this contact, I will be doing a joint research project and collaborating on a paper with Colin Gilligan, one of my Sheffield hosts. I gained a good friend and a professional colleague."

In April Daniel Tesson, assistant professor in the department of accounting, went to Sheffield's department of accountancy and company administration where he conducted four student and two faculty seminars.

Tesson compared the Sheffield and RIT accounting curricula, identifying how to accommodate students who want to participate in exchanges. "Sheffield City Polytechnic has an annual program with a final exam at the end as opposed to RIT's quarter system," Tesson explains.

"Students get feedback during the year but only one grade. They seem to develop a broad perspective of the profession with that arrangement, but there are problems of flexibility. They also have no liberal arts, an important part of an RIT education no matter what the discipline."

This month Dr. Robert Barbato, assistant professor in the department of management, will discuss entrepreneurship and small business management, subjects he teaches MBA students at RIT, with faculty and students at Sheffield City Polytechnic's department of management studies. "I'm

According to RIT's Personnel Office, the United Way of Greater Rochester can provide child care subsidies for qualifying parents through its Office of Child Care Services.

There are 20 group day care centers in city centers as well as in Greece, Webster and Charlotte, and there are 60 family day care homes in the city and several towns.

Parent fees are set on a sliding scale, according to income and size of family. Subsidies are available at incomes up to \$22,000 for a family of two and slightly higher for larger families.
