5.) Senator Report

NTID: I have been working on my goal for the RTS bus system. There has been a problem b/c they have a limited schedule in the morning. Also the bus drivers attitudes toward people with handicaps are not nice. Several deaf students have had problems. I got a schedule here and you can see that there are no buses until the evening. You have to wait un5:56 on weekends to go off campus. Rick LaClaire is the director for public transportation and he is going to get intouch with RTS bus service. I have a petition and I am looking to get more people to sign.

RHA: Can we sign the petition?

NTID: Absolutely, pass it around.

NSC: Concern of the NTID Community is that there are not many deaf people included in the orange and brown Fridays. We are concerened about how we can get ntid community involved. Working with my vice president to get more attendance at pulse happy hour. Every two weeks on Friday from 4-6. There are a lot of ntid students who have come up to me, and they want captioning on the tv with the senate meeting.

- 9.) Old Business
 - a. Discussion on clubs

GLBT: Motion to discuss.

CAST: Second

VP of NSC: Where is the opportunity for students to become leaders if you consolidate all the clubs.

Rep @ Large: This is for clubs that have not been recognized.

NTID: I was thinking that it would be a good idea to have hearing MSO's and NTID MSO's. Some deaf students are afraid to approach the hearing groups. I think it would be better if the deaf clubs could be left there.

KGCOE: We want to keep it just clubs, not MSO's and existing clubs. Just clubs that are applying for recognition.

RHA: If recognized clubs aren't allowed to have the same purpose, then we should allow a wider range of clubs. Then they could still be affliated.

Programming: For students with 15000 students if students want a certain club, we should make them happy.

GCCIS: The minimum size of a club is 10 people. You are saying that you have to have 10 people and they have to be different from another club. It comes don't to them presening themselves.

Bob: Clubs that form on their own, do you want SG to be involved in that or do you want to ignore it.

Rep: Some karate club wanted to be affiliated and they weren't and they wanted an interpreter and they didn't get one.

Global Union: What if a new club needs to have an affiliation with an existing club?

NSC: Maybe clubs could be examined at the same time. I'm wondering if we could have clubs just be affiliated.

Rep: Recognized clubs are catered to, they have lots of services. Affiliated clubs just get a meeting space.

Reporter: Why do they just get a place to meet and not get interpreters?

Rep: We haven't discussed why they just get a meeting space, but if they have a meeting space they can get an interpreter.

SCOB: Why wouldn't clubs want to be affiliated when anyone can get space on campus? We aren't giving them enough services.

KGCOE: I have asked about that. What services can we offer without burdening the CCL? There are things I envisioned that affiliates should get when its not really a possibility. Let us know if there are services that you would like to see offered.

Rep: It is a pilot for winter quarter.

VP of NSC: Affiliated clubs don't get any money or anything correct? I don't see much of a problem if we want to have affiliated clubs. If they want to be recognized then more work has to be done.

Rep: It's a good issue; interpreters. We will be checking that out.

Bob: what is the difference between tier zero and affiliates?

KGCOE: They are the same. Tiers are for the budget ranking system. They were called that last year b/c that is the name I decided. We later decided that it wasn't appropriate.

PR: I have this sense of feeling that we are over examining. It should be a case by case study.

Rep: There needs to be a line that is drawn. The senate needs to help with that. PR: Could clubs just present and then they can decided. I feel like is closing the doors.

Rep: Its not closing the doors we are just setting guidelines that the senate needs to set.

GCCIS: To go back on the option of forming a club would hurt us. We are in the acceptable range of clubs.

Bob: If the second club is doing better

GLBT: I work in the admissions office and when we give tours we discuss starting your own club. We inform students there are over 160 clubs and if you aren't interested in those, you can form your own. You shouldn't have a recognized club and an affiliate club, they should be the same.

CAST: Our goal is to bring students together. We should encourage the groups to talk. We should mainly encourage groups to form as one.

NTID: Our responsibility is to bring unity to the students. We should help groups out.

KGCOE: Before we continue do you wan a decision today? I was going to wait for voting for Ed and Sasha.

GCCIS: Motion to continue discussing.

COLA: Second

PR: Maybe we could make more work for the person who wants to form a new club. The more info the club review board has the easier it will be.

Rep: Tiers are just for finances.

Erica: I think if we limit the number of affiliations we have we are limiting leadership opportunities for students. I don't see the problem. Perhaps there could be a deeper analysis of this.

KGCOE: We are adding a new path to recognition. There are clubs right now that fly uner the radar of this, and there always will be. If we combine two clubs b/c they have the same interests. The people who are leaders will find the leadership roles within the clubs. I think we are ignoring that fact that there will be clubs that are flying under the radar.

GLBT: I think there should be one club. Instead of having two different clubs, there should be one ebaord with sub groups.

Erica: I don't see why we can't have two similar clubs. Why can't there be a process for affiliations to say why they don't want to be an affiliate.

GCCIS: We need to treat affiliate and recognized as the same thing.
